History

The Governor's Council on Disability traces its roots to the World War II era. In 1947, President Harry S Truman issued an Executive Order establishing the President's Committee on Employment of the Handicapped. This Committee was created to assist WW II veterans living with disabilities with reentry into the civilian workforce. In 1949, Missouri established the state Governor's Committee to share information about work related problems facing people living with disabilities. In 1977, the Governor's Committee was established as a state agency and in 1994, the statute was updated to broaden the agency's mission beyond employment, enabling the Governor's Council on Disability to become a voice for more than one million Missourians living with disabilities in all facets of life, including state government.

Mission

To provide leadership and support so people with disabilities achieve inclusion and independence.

Vision

The Missouri Governor's Council on Disability will be recognized statewide as the primary organization providing leadership to improve the lives of Missouri citizens with disabilities.

Goals

The Missouri Governor's Council on Disability's Strategic and Operational Plan was reviewed and updated for 2020 - 2022 on August 23, 2019. The Goals are:

- Goal I: Advise all state agencies and non-governmental organizations to advocate for policies and practices that impact Missouri citizens with disabilities.
- Goal II: Encourage system changes and public policies that eliminate barriers and support the wellbeing and independence of individuals with disabilities.
- Goal III: Expand opportunities for independence for people with disabilities in all aspects of their lives.
- Goal IV: Gather input from the public on disability related issues and report the results of this information.
- Goal V: Develop, explore, and implement strategies to increase resources for and the operating efficiency of the Council.

- Council members are appointed by the Governor.
- The appointment of the chairperson requires the advice and consent of the Missouri Senate.
- Members represent each of the eight U.S. Congressional Districts.
- The majority of members are people with disabilities.
- The Governor's Council on Disability is comprised of the following committees: Executive, Advocacy, and Programs.
- The Council conducts quarterly meetings.
- Currently, four seats are vacant.



- GCD staff participated in the National Association of Youth Leadership Forums.
- GCD Executive Director participated in the National Association of Governor's Councils.
- GCD published six issues of the GCD newsletter covering disability-related topics.

Finances

All but one of the Governor's Council on Disability's programs are funded from General Revenue. This funding covers personnel costs and expenses for most Council activities. The Fiscal Year 2021 (July 1, 2020 – June 30, 2021) budget is listed below:

Operating Expenses:	<u>\$ 21,181.00</u>
Total:	\$202,811.00

At the time of publication, the Council has spent \$1,940.70 in operating expenses, or 9% of the FY21 budget. Expenses include supplies, postage, telecommunications, Council meeting expenses, travel, professional development, disability accommodations, and expenses for GCD programs.

The Missouri Youth Leadership Forum (MO-YLF) and Regional Leadership Forums (RLF) are programs that are **not** funded from General Revenue funds. These programs are funded through a combination of private donations and sponsorships.

Paraquad, Inc., a Center for Independent Living in St. Louis, serves as the 501(c)3 fiscal agent for the MO-YLF and RLF account.


Programs and Initiatives

Technical Assistance

The Governor's Council on Disability (GCD) provides disability-related technical assistance to individuals, businesses, governmental and agency representatives from all over the state, and from other states, by phone, letter, or e-mail. Most contacts are from individuals in need of resources in order to live more independently. Referrals are made to Centers for Independent Living, state and federal agencies, local community resources, non-profit organizations, including faith-based groups and Community Action Agencies. In some instances, referrals are made to businesses or for-profit entities. The GCD also works with a number of state legislators and the Governor's Office on constituent affairs to provide solutions to individuals' concerns and issues.

In 2020, the GCD received a substantial number of calls and e-mail inquiries concerning financial assistance, service animals, disability services, housing, employment and legal/advocacy issues. Other common inquiries included requests for information about transportation, accommodations, ADA guidelines and regulations, Universal Design standards, accessible parking, FMLA issues, eligibility requirements for disability benefits, and questions about potential discrimination in employment, housing or in public places.

Overall, the GCD assisted 355 different individuals with their phone inquiries and responded to 787 e-mail inquiries and requests.

Publications / Resources

Disability Web Portal and Directory of Resources for Missourians with Disabilities

The Governor's Council on Disability publishes a variety of educational videos, resources and information on the <u>Disability Web Portal</u>, including the *Resource Directory for Missourians with Disabilities*. The online Directory allows each user to search for disability-related resources by category or location.

COVID-19 Resources

The Governor's Council on Disability created a website designated to resources and information related to the coronavirus pandemic, including a *Face Mask Guidance and Reasonable Accommodations* document published in collaboration with the Missouri Commission on Human Rights and the Missouri Department of Labor and Industrial Relations.

Legislative Update

During the legislative session, a weekly <u>Legislative Update</u> is distributed to keep individuals up-to-date on legislation that potentially impacts individuals with disabilities. Over 1,200 individuals subscribed to the publication via email and regular mail in addition to the website.

GCD Newsletter

The GCD publishes six issues of the GCD Newsletter per year about disability-related topics and GCD activities. The newsletter is sent out by email and posted on the website and Social Media. The newsletters can be found online at <u>http://disability.mo.gov/gcd/newsletters.htm</u>

Accessible Parking PSA

The Governor's Council on Disability, in collaboration with the Office of Administration's IT division and Missouri State Highway Patrol, developed a public service announcement video to educate about the importance of accessible parking spaces for individuals with disabilities, and to remind people to keep access aisles open for those who need them to transfer in and out of the vehicles. The <u>Inclusion Award</u> recognizes individuals or organizations that have demonstrated best practices in inclusion of people with disabilities in education, employment, housing, leisure activities, universal design, and website accessibility. The Council's Programs Committee selects the winners of the Inclusion Awards, who are nominated by individuals or organizations in their communities.

Artists First is an inclusive art studio empowering artists of all abilities and bringing art to the community as a means of integration, healing, support and finding common ground. Through innovative art programs, Artists First supports more than 225 individuals and connects them to the resources they need to grow socially, intellectually, and emotionally through creative self-expression. Artist First's participation in over 45 community events in 2019 provided opportunities for genuine community involvement and allowed artists with

disabilities to be integrated into the art community and labor market.

Boone Center, Inc. established BCI Skills Center in January 2019 as a first-of-its-kind vocational training facility for people with disabilities. BCI Skills Center partners with local businesses that embrace diversity to create custom programs to prepare individuals living with disabilities for employment. Upon graduation, students move directly into the integrated workforce and earn competitive wages.

Legislative Programs

Legislative Education Project

The purpose of the <u>Legislative Education Project</u> (LEP) is to educate people about the Missouri legislative process and motivate individuals by providing opportunities to become actively involved in public policy that impacts people with disabilities. The LEP is sponsored annually during the legislative session and includes online learning tools, the *LEP at the Capitol*, and the *LEP on the Road* to bring the training to individuals and organizations in their communities. During the 2020 legislative session, 67 individuals participated in the LEP.

The online training modules and videos teach individuals about *How a Bill Becomes a Law*, the *Elected Officials and General Assembly*, and *How to Navigate the House and Senate Websites*. The videos educate about *Accessible Voting*, *Attending a Senate Hearing and Providing Testimony*, and *Building an Effective Relationship with Legislators*. The online learning modules and videos have had more than 1,800 views.

Legislative Priorities Poll

Each year the Governor's Council on Disability distributes a Legislative Priorities Poll to determine the issues that are important to Missourians with disabilities and those who work and live with them. The poll is sent out to agencies and individuals. This year, 372 individuals from 54 counties in Missouri participated in the poll. Based on the results, the legislative priorities the Governor's Council on Disability will be following during the 2021 legislative session are:

- 1. Plans for public emergencies and disasters ensuring needs of people with disabilities are met
- 2. All public buildings having evacuation plans for all people with disabilities
- 3. Accessible voting machine provided at each polling location to comply with federal law
- 4. Private insurance hearing aid coverage
- 5. The increasing cost of medications

The GCD will continue to help people with disabilities advocate in the 2021 legislative session. GCD staff will be examining bills that relate to disability and analyze their impact on the disability community.

Legislative Update


The Governor's Council on Disability will continue to publish the weekly <u>Legislative Update</u> newsletter during the legislative session to provide information about disability-related bills and their status in the legislative process.

Missouri Youth Leadership Forum

The annual Missouri Youth Leadership Forum (MO-YLF) is a 5-day leadership and career development program for transition aged students with disabilities. The 2020 MO-YLF had to be canceled due to the COVID pandemic. Plans are underway to continue the program in the summer of 2021.

In collaboration with the Office of Administration's IT division, GCD staff developed a web application for the MO-YLF this year to make the application process and program administration more user-friendly and efficient.

Since inception of the program in 2001, a total of 344 alumni have graduated from the Missouri Youth Leadership Forum, representing 70 of the 114 Missouri counties, plus the city of St. Louis.



The 2021 MO-YLF will be held at the MU campus in Columbia from July 13-17, 2021. (Tentative dates)

Regional Leadership Forums

To continue and expand the mission of the Missouri Youth Leadership Forum, the GCD and its partnering agencies initiated the development of Regional Leadership Forums (RLF) in four different locations around the State of Missouri.

These new, one-day leadership training programs provide transition age students the opportunity to learn about leadership, self-determination, employment, goal setting, and independent living, and prepare them for the week-long Missouri Youth Leadership Forum. The RLFs are also intended to increase the statewide outreach by providing leadership opportunities in different regions of the state.

The RLFs are scheduled to be held in Jefferson City, Kansas City, Springfield and Cape Girardeau during March and April, 2021.

ADA Anniversary Celebration



July 26, 2020 marked the 30th anniversary of the Americans with Disabilities Act (ADA), which was celebrated nationwide throughout the month of July and the rest of the year, with webinars, documentaries, and events.

On Tuesday, July 28, 2020, Missouri celebrated this milestone with an event at the Missouri State Capitol in Jefferson City and via Facebook live. Several dozen

individuals attended the event at the capitol while thousands viewed it online.

The Governor's Council on Disability partnered with other state agencies and disability organizations to host the event.

Speakers included Governor Michael L. Parson and Jefferson City Mayor Carrie Tergin, who presented proclamations to celebrate the anniversary and designate July 26 as Americans with Disabilities Act Awareness Day, and Attorney General Eric Schmitt. Amber Cheek with the MU Division of Inclusion, Diversity and Equity, and Julie Brinkhoff with the Great



Plains ADA Center spoke to honor and celebrate the legacy of former Council member and state legislator Chuck Graham. Missouri Youth Leadership Forum alumna Madelyn Hubbs provided her perspective of a member of the ADA generation born after the passage of the ADA.

Sam Doman, a violinist from Wardsville, played classical music during a slideshow of ADA Successes and Visions for the Future highlighting the accomplishments and successes of the ADA in the last three decades and visions for the future of inclusion and accessibility.


Employment Initiatives

Missouri as a Model Employer Initiative

On February 1, 2019, Governor Mike Parson announced the State of Missouri's participation in the Missouri as a Model Employer Initiative to increase employment opportunities for people with disabilities in state government, create a more diverse workforce, and serve as a model for Missouri businesses. The initiative was supported by the US Department of Labor's Office of Disability Employment. The Governor's Council on Disability had the opportunity to serve on this initiative along with representatives from various state agencies, a center for independent living, and the Missouri Chamber of Commerce. This year, efforts focused on developing and publishing training content for state HR and hiring managers, supervisors and employees. Disability Employment Awareness Month Poster Contest

The Governor's Council on Disability (GCD) hosts an annual poster contest to celebrate Disability Employment Awareness Month in Missouri and raise awareness about the importance of workplace inclusion for people with disabilities. National Disability Employment Awareness Month (NDEAM) is observed each year in October to celebrate the contributions of workers with disabilities and educate about the value of a workforce inclusive of their skills and talents.



The poster contest is intended to spark a conversation about the importance of employment for people with disabilities and raise awareness about their positive contributions to the workforce.

The winner of the 2020 Disability Employment Awareness Month contest was Susie Dains, Lake Ozark, Missouri. The poster was distributed statewide during the month of October, featured in the GCD Newsletter, and posted on the GCD website and social media.

National Disability Employment Awareness Month (NDEAM)

This year marked the 75th anniversary of National Disability Employment Awareness Month, which was celebrated nationwide throughout the month of October. The GCD created a virtual exhibit about the history and background of NDEAM, featuring resources and information related to the employment of individuals with disabilities, which can be found on the Disability Web Portal at <u>https://disability.mo.gov/NDEAM.htm</u>

Disability Web Portal / Website / Social Media

- The Missouri Disability Web Portal serves as a one-stop access point for the public to obtain information on disability resources and offers links to other entities and state agencies that provide services to people with disabilities. In 2020, the Disability Web Portal had 76,520 page views. <u>http://disability.mo.gov</u>

- Missouri Youth Leadership Forum Facebook page with more than 380 Page Likes/Followers

- Over 1,500 individuals are subscribed to GCD listservs to receive disability-related information by email

Educational Presentations / Outreach / Exhibits

The Governor's Council on Disability provides educational programs on disability rights, etiquette and awareness, employment of people with disabilities, service animals and other disability-related topics to any state agency, group or organization in Missouri requesting such information. Educational programs are specifically tailored to the individuals or groups to ensure effectiveness. During most quarterly public Council meetings, a presentation is provided on different disability-related topics. This year, the decreased numbers in outreach, presentations, and exhibits are a result of program, conference and event cancellations due to the COVID-19 pandemic. During 2020:

- GCD staff developed and presented 39 educational programs to 4,196 individuals around the state
- GCD provided outreach to 516 individuals at 40 meetings and events throughout the year
- GCD provided information and resources to 749 people through exhibit booths at 6 conferences and transition events
