On behalf of the Governor's Council on Disability (GCD), a division within the Office of Administration, I am pleased to present the 2025 Annual Report. This report highlights the GCD's ongoing efforts, accomplishments, and continued commitment to fostering full participation, access, and opportunity for Missourians with disabilities across all areas of community living.

As an advisory council to state leadership, the GCD serves as a vital resource for citizens, state agencies, businesses, and organizations. Our work is dedicated to advancing understanding of the rights and responsibilities established under the Americans with Disabilities Act (ADA) and related state and federal legislation. Through education, outreach, and collaboration, the GCD strives to promote equitable opportunities and inclusive practices throughout Missouri.

A key responsibility of the GCD is the management of the State of Missouri's Disability Portal, which offers a comprehensive collection of disability-related resources, tools, and guidance for individuals with disabilities, families, employers, and service providers. In addition, the GCD provides educational training programs focused on disability awareness, accessibility, and compliance, helping organizations and communities better serve all Missourians.

Employment remains a central focus of our work. The GCD actively engages in supporting and advancing Missouri's Model Employer Initiative, promoting state government as a leader in the employment of individuals with disabilities. By partnering with state agencies and community stakeholders, we continue to promote inclusive hiring and employment practices and economic opportunity statewide.

The GCD also plays an important role in civic engagement by informing citizens about the legislative process in Missouri and offering educational programs that encourage and empower individuals with disabilities to participate in legislative and policy-making efforts. These initiatives help ensure that the voices of Missourians with disabilities are heard and represented in decisions that impact their lives.

Additionally, the GCD's Missouri Youth Leadership Forum program supports high school students with disabilities by equipping them with essential learning and leadership skills. This program is designed to promote successful transitions from high school to postsecondary education, vocational training, or employment, fostering independence and long-term success.

We appreciate the continued support of state leadership and the citizens of Missouri as we work to advance access and opportunity for all.

## **History**

The Governor's Council on Disability has its origins in the World War II era. In 1947, President Harry S. Truman issued an Executive Order that led to the creation of the President's Committee on Employment of the Handicapped. This Committee was designed to help WWII veterans with disabilities reintegrate into the civilian job market. By 1949, Missouri formed its own Governor's Committee to address work-related challenges faced by individuals with disabilities. In 1977, the Governor's Committee was officially designated as a state agency, and in 1994, it underwent a name change and a statute update to expand its mission beyond just employment. This transformation allowed the Governor's Council on Disability to represent over one million Missourians with disabilities across various aspects of life, including state government.

### **Mission**

To provide leadership and support so people with disabilities achieve inclusion and independence.

## **Vision**

The Missouri Governor's Council on Disability will be recognized statewide as the primary organization providing leadership to improve the lives of Missouri citizens with disabilities.

## Goals

The Governor's Council on Disability's Strategic and Operational Plan was updated and approved for 2023 - 2027 on November 18, 2022. The Goals are:

Goal I: Advise all state agencies and non-governmental organizations to advocate for policies

and practices that impact Missouri citizens with disabilities.

Goal II: Encourage system changes and public policies that eliminate barriers and support the

wellbeing and independence of individuals with disabilities.

Goal III: Expand opportunities for independence for people with disabilities in all aspects of their

lives.

Goal IV: Gather input from the public on disability related issues and report the results of this

information.

Goal V: Develop, explore, and implement strategies to increase resources for the operating

efficiency of the Council.



## **Finances**

The Governor's Council on Disability's programs and services are funded from General Revenue, with the exception of the youth transition program. This funding covers personnel costs and expenses for most Council activities.

The Fiscal Year 2026 (July 1, 2025 – June 30, 2026) budget is listed below:

At the time of publication, the Council has spent/encumbered \$9,246 in operating expenses, or 36% of the FY26 budget. Expenses include supplies, postage, telecommunications, Council meeting expenses, travel, professional development, disability accommodations, and expenses for GCD programs.

The Missouri Youth Leadership Forum (MO-YLF) program is **not** funded from General Revenue funds. This program is funded through a combination of sponsorships and donations. Paraquad, Inc., a Center for Independent Living in St. Louis, serves as the 501(c)3 fiscal agent for the program.



## **Programs and Initiatives**


#### **Technical Assistance**

The Governor's Council on Disability (GCD) provides disability-related technical assistance to individuals, businesses, governmental and agency representatives in Missouri, and other states. The GCD provided critical guidance and connected people to trusted state and federal partners, community-based independent living centers, nonprofit organizations, and, when appropriate, forprofit service providers. The GCD continued to collaborate closely with state agencies, legislators, and the Governor's Office on constituent matters to resolve complex concerns and deliver meaningful solutions.

The highest demand for technical assistance centered on Social Security benefits and financial assistance, service and emotional support animals, housing resources, and ADA compliance – reflecting the essential role our agency plays in helping individuals navigate the systems that support independent living.



Overall, the GCD assisted 419 different individuals with their phone inquiries and responded to 595 email inquiries and requests.

#### **Publications / Resources**

#### Disability Web Portal and Directory of Resources for Missourians with Disabilities

The Governor's Council on Disability publishes a variety of educational videos, resources, and information on the <u>Disability Web Portal</u>, including the *Resource Directory for Missourians with Disabilities*. The online Directory allows each user to search for disability-related resources by category or location.

#### **Legislative Update**

During the legislative session, a weekly <u>Legislative Update</u> is distributed to keep individuals up to date on legislation that potentially affects individuals with disabilities. Over 1,240 individuals subscribed to the publication.

#### **GCD Newsletter**

The GCD publishes six issues of the GCD Newsletter per year about disability-related topics and GCD activities. The newsletter is sent out by e-mail and posted on the website and social media. The newsletters can be found online at <u>disability.mo.gov/gcd/newsletters.htm</u>

## **Awards Programs**

The Governor's Council on Disability annually recognizes individuals or organizations who promote and demonstrate leadership in inclusion of individuals with disabilities in all aspects of community living. Recognizing best practices in Inclusion and outstanding efforts in Youth Leadership increases awareness about the importance of inclusion in all aspects of community living and awards accomplishments in advocacy efforts for the disability community. The Council selects the winners of the awards, who are nominated by individuals or organizations in their communities.

#### **Inclusion Award**

The <u>Inclusion Award</u> recognizes individuals, businesses, agencies, or organizations that have implemented innovative measures to incorporate people with disabilities into their programs, activities, and operations.

True Manufacturing showcases leadership in disability inclusion through its collaboration with the BCI Skills Center. Over five years, the company has created a job training program for adults with intellectual and developmental disabilities, hiring 51 graduates with a 76% retention rate. Their inclusive hiring practices have strengthened their workforce and earned the 2024 Talent Pipeline Project of the Year award, showcasing the impact of equal opportunities in employment.

Lucas Fritsche has significantly impacted his community through his commitment to inclusion and accessibility. His journey began when he noticed a friend being unable to enjoy recess due to an inaccessible playground. This prompted him to advocate for an inclusive playground, leading to the Lucas and Friends Backyard Adventure project, which opened in 2021. Lucas's efforts have transformed his community and exemplify how young voices can drive meaningful change.

## **Legislative Programs**

### **Legislative Education Project**

The purpose of the <u>Legislative Education Project</u> (LEP) is to educate people about the Missouri legislative process and empower individuals by providing opportunities to become actively involved in public policies that impact people with disabilities.

The LEP is sponsored annually during the legislative session and includes online learning tools as well as educational webinars for individuals and organizations.

The online training modules and videos teach individuals about *How a Bill Becomes a Law*, the *Elected Officials and General Assembly*, and *How to Navigate the House and Senate Websites*. The videos educate about *Accessible Voting*, *Attending a Senate Hearing and Providing Testimony*, and *Building an Effective Relationship with Legislators*.

The online learning modules and videos had 2,980 views, and 95 individuals participated in four LEP webinars during the legislative session to learn about the legislative process, how to get involved in advocacy, and hear about pending legislation that would affect the disability community.

#### **Legislative Priorities Poll**

Each year the Governor's Council on Disability distributes a Legislative Priorities Poll to determine the issues that are important to Missourians with disabilities and those who work and live with them. The poll is sent out to agencies and individuals. This year, 346 individuals from 59 counties in Missouri participated in the poll. Based on the results, the legislative priorities the Governor's Council on Disability will be following during the 2026 legislative session are:

- 1. The State of Missouri updating websites to include more language that is direct and easy to understand for those with reading or writing difficulties
- 2. The Personal Care Attendant/Aide/Direct Support Professional workforce providing critical services
- 3. Funding needs
- 4. Transportation needs

Outcomes of the Legislative Priorities Poll are shared with the General Assembly and elected officials. The GCD will continue to help people with disabilities advocate in the 2026 legislative session. GCD staff will be examining bills relating to disability and analyze their impact on the disability community.

#### **Legislative Update**

The Governor's Council on Disability continues to publish the weekly <u>Legislative Update</u> newsletter during the legislative session to provide information about disability-related bills and their status in the legislative process.

#### **Disability Rights Legislative Day**

The Governor's Council on Disability works in partnership with the Missouri DD Council and other disability agencies and organizations to organize the annual Disability Rights Legislative Day (DRLD).

The event took place on February 26, 2025, at the state capitol in Jefferson City and online. Over 500 individuals and organizations from Missouri's disability community participated in the event, both in person and virtually.

Attendees who joined in person had the opportunity to connect with representatives from disability-focused organizations to get information about their resources and services.

Participants received information on how they could engage with various legislative issues and were encouraged to meet with legislators. A rally in the capitol rotunda featured a range of speakers discussing crucial disability-related topics.



Transportation, employment, and access to services were the focus of the day. The keynote speakers were all individuals with disabilities, family members, or service providers in addition to legislators and elected officials. Governor Kehoe who was introduced by Representative Stinnett attended his first DRLD as governor.

## Missouri Youth Leadership Forum

The <u>Missouri Youth Leadership Forum</u> (MO-YLF) is a five-day leadership and career development program designed for transition-age high school students with disabilities. From July 15–19, 2025, the 21st annual MO-YLF convened at the University of Missouri in Columbia, hosting twenty (20) delegates

representing fourteen different counties.

The intensive curriculum covered essential topics including self-advocacy, disability culture and history, the legislative process, independent living, and assistive technology.

This program offers students a unique chance to learn from mentors, alumni, and volunteers who share similar lived experiences with disability,



advancing their growth as leaders within their communities. Delegates experience a preview of college life while attending the program and gain insights into career and higher education opportunities through discussions with an employer panel and post-secondary education experts. A legislative day at the capitol allows participants to explore the legislative process and the importance of self-advocacy, while a community service project emphasizes the significance of volunteering. Small group activities were led by sixteen (16) returning alumni who served as facilitators and team leaders, providing these young leaders an opportunity to grow and build on their leadership skills. Evening social activities provide opportunities for bonding and the formation of lasting friendships.



Since inception of the MO-YLF in 2001, 433 alumni have graduated from the Missouri Youth Leadership Forum, representing 74 of the 114 Missouri counties, plus the city of St. Louis.

## **Employment Initiatives**

#### Missouri as a Model Employer Initiative

In 2019, Governor Parson issued <u>Executive Order 19-16</u> outlining directives for state agencies to implement the Missouri as a Model Employer initiative. Members of the Office of Administration's Division of Personnel, Office of Equal Opportunity, and the Governor's Council on Disability collaborate to assist executive agencies in carrying out the directives of EO19-16. In 2025, these efforts focused on:

- Conducting the annual self-disclosure survey of state team members and evaluating data
- Collaborating with agency ADA coordinators and HR directors to develop agency implementation
  plans for the Model Employer initiative and create annual action items based on team member
  feedback in the self-disclosure survey
- Reviewing and assuring accessibility of hiring platforms and state government websites in collaboration with the OA ITSD division
- Developing a statewide training curriculum on disability awareness, accommodations, accessibility, and employment laws for all state agencies
- Providing training and educational presentations on disability awareness, etiquette, and employment practices
- Hosting inclusive hiring events and targeted outreach activities
  - Talent Showcase Hiring Events
  - Statewide Hiring Events (in person and virtual)
- Hosting statewide awareness events to promote employment inclusion
  - National Disability Employment Awareness Month (NDEAM) Celebration and Resource Event
  - NDEAM Poster Contest


Missouri was selected to participate in the National Expansion of Employment Opportunities Network (NEON) initiative which enables government agencies to receive capacity-building support, policy development assistance and ongoing mentoring to increase competitive integrated employment for people with disabilities. Missouri's NEON workgroup is a collaborative workgroup of state agencies and national Subject Matter Experts working in tandem with the OA Model Employer workgroup to carry out the directives of Executive Order, Model Employer Legislation, and Employment First Legislation. The NEON workgroup focused on:

- Developing an MOU between state agencies for the implementation of the Employment First legislation
- Creating a comprehensive training presentation on the Model Employer and Employment First initiative
- Facilitating connections between state agencies and agencies supporting people with disabilities in employment

#### **Disability Employment Awareness Month Poster Contest**

The Governor's Council on Disability organizes a yearly NDEAM <u>poster contest</u> to honor Disability Employment Awareness Month in Missouri, aiming to highlight the significance of employment inclusion for individuals with disabilities.



The 2025 NDEAM poster contest winner was Evelyn Johnson, who was recognized for her outstanding artwork at the statewide NDEAM celebration event.



#### **National Disability Employment Awareness Month (NDEAM)**

National Disability Employment Awareness Month is celebrated nationwide throughout the month of October to raise awareness about disability employment issues and celebrate the contributions of America's workers with disabilities. The GCD participated in several NDEAM activities including:

- Collaborating with the Office of Equal Opportunity to co-host the inaugural statewide NDEAM celebration and exhibit hall of notable Missourians with disabilities on October 10
- Receiving a proclamation from Governor Kehoe designating the month of October as National Disability Employment Awareness Month in Missouri
- Providing a virtual exhibit about the history and background of NDEAM, which features resources
  and information related to the employment of individuals with disabilities

- Participating in employment initiatives and NDEAM employment conferences and events
- Raising awareness through newsletter articles, social media, and email communications, educational presentations, and the NDEAM poster contest

## **Outreach Activities**

The Governor's Council on Disability participated in numerous outreach and educational activities throughout the year to promote disability awareness and inclusion of people with disabilities in all aspects of life.

#### Disability Web Portal / Website / Social Media

- The Missouri Disability Web Portal (<u>disability.mo.gov</u>) serves as a one-stop access point for the public to obtain information on disability resources and offers links to other entities and state agencies that provide services to people with disabilities. The portal also provides a link to the GCD website. In 2025, the Disability Web Portal and GCD website had 164,412 page views.
- **Social Media:** The GCD Facebook page is reaching a growing number of individuals with 2,392 followers. GCD's Twitter/X account has 239 followers to date and the GCD's newly created LinkedIn page has 157 followers. The Missouri Youth Leadership Forum Facebook page has 734 followers.
- **Email subscribers:** Over 2,100 individuals are subscribed to GCD listservs to receive disability-related information and GCD program updates.

#### **Educational Presentations / Outreach / Exhibits**

The Governor's Council on Disability provides educational programs on disability rights, etiquette and awareness, employment of people with disabilities, service animals and other disability-related topics to state agencies, groups or organizations in Missouri requesting such information. Educational programs are specifically tailored to the individuals or groups. During the quarterly public Council meetings, presentations are provided on different disability-related topics.

Throughout the year 2025, the GCD staff:

- Developed and presented 40 educational programs and presentations to 1,598 individuals.
- Provided outreach and shared resources and information with 5,128 individuals at 48 meetings, events, and conferences.
