Katheryne Staeger-Wilson with the Missouri DD Council presented on the **Olmstead White Paper** prepared by the MO DD Council's Olmstead Subcommittee. Andre Alexander presented on the **Tabernacle Community Development Housing Program** in St. Louis which provides safe, affordable, and accessible housing and community centers to connect residents with resources.

State Liaison Reports:

Kelli Kemna (DMH/DD) announced HBCS Wait List Webpage - https://dmh.mo.gov/dev-disabilities/waiting-list. Amendments to increase waiver slots were submitted to MHD. MHD submitted to CMS. Partnership for Hope-500 slots (200 Supplemental, 300 FY26). Community Support Waiver- 1,544 slots (1,044 Supplemental, 500 FY26). Comprehensive Waiver- 636 slots (182 Supplemental, 454 FY 26). Missouri Children's with Developmental Disabilities- 50 slots. Family Flexible Assistance Program FY26 Funding for East and Northwest Autism Projects - https://dmh.mo.gov/sites/dmh/files/media/pdf/2025/06/53000a.pdf.

Louis Gatewood (DESE/VR) stated there is currently a waitlist of around 300 people. The Program Year Accomplishments for 2024 were: VR served 27,155 individuals statewide, they had 3,774 successful outcomes for employment within 90 days or greater. They had 2,309 potentially eligible students served by VR Counselors that had an IEP or four or five medical conditions and the Median Hourly Wages were \$15.00 per hour, 4,585 individuals received a Measurable Skill Gains (MSG), and over 1,833 individuals either graduated with a secondary diploma or post-secondary degree.

Chad John (MDC) stated that MDC just received an accessibility audit, so they have a few items to address. Most of the structures existed before the ADA was passed and the department is doing a very good job of prioritizing the time and money to address those on an ongoing basis. MDC is in the process of creating an online ADA training for their staff that will be available through their LMS system on an ongoing basis.

Joshua Shewmaker (DOR) stated that he had a legislator reach out to ask why individuals with disabilities must apply for a disabled placard every 8 years and provide medical documentation verifying their disability instead of submitting documentation only once. Ron offered to provide information on the topic to the legislator if needed.

Chiquita Small (DESE/MSSD) stated the State Board of Education approved the reorganization of locations of Missouri Schools for the Severely Disabled.

Shomari Rozier (DHSS) stated that Prescribed Pediatric Extended Care (PPEC) is being established as a state plan service for children with medical complexities to receive multidisciplinary care through an integrated day

program setting. PPEC licensure will be required by August 28 for any facility providing PPEC services. However, MHD system work to allow for PPEC claims payments is still ongoing with full implementation expected February 2026. DSDS and MHD are working diligently to establish an alternative claims payment option to pay providers until then.

DSDS will be launching another year of the National Care Indicator Aging and Disability Consumer Survey in October. This survey is operated by HCBS participants Human Services Research Institute. The indicator in the survey helps states understand how the DSDS publicly funded services and supports impact their quality of life. The indicators go beyond simple measures of health and safety; they also address important personal outcomes such as community engagement, independence, decision-making, self-direction and other personcentered components of a quality life. This survey was historically optional however with the implementation of the Access Rule it is now a requirement of states to have a valid sample of consumer completing the survey. Any support in raising awareness about the importance of participation would be appreciated.

DSDS will also be releasing another round of the National Core Indicator State of the Workforce Survey in September. The survey captures information about wages, benefits, and turnover of the direct care professional workforce, hired by agencies. These metrics will help DSDS identify and understand the factors that influence service delivery, which helps inform policy and fiscal initiatives.

Home and Community Based Services Provider Information Webpage Update - The Department of Health and Senior Services (DHSS) is undertaking a department-wide initiative to update its website. The initiative aims to increase user navigation and accessibility.

Show-Me Home (SMH)/MFP:

The bidding and evaluation process to select SMH contractors for regions 1, 2 & 4 for the remainder of 2025, have been completed, and awards should be announced soon.

The SMH program will be hiring a new DSDS SMH Services Specialist for the vacant Region 5 position (Mid-Missouri)

The SMH program will be continuing its collaboration with the UMKC Institute for Human Development for the foreseeable future, as we work towards a highly anticipated in-depth training program for SMH contractors and DSDS/DSS SMH staff, that will benefit all aspects of the program. This will also include the development of a SMH Peer Mentor position that will interact with residents, family and friends, to determine what's right for the resident, in addition to other duties. Past studies have shown that this position is better served being outside the confines of policy and regulatory interactions with residents

The Show Me Home Program was awarded two new contracts to NEILS and Circle of Care, the third contract is pending.

Phoenix Jenks (DNR) stated DNR is focusing on raising awareness of available ADA campsites, Track Chairs, and Beach Chairs in State Parks. While DNR has 6 track chairs and 18 beach chairs available, they are rarely being used. The idea is that when someone requests an ADA accessible campsite, the system will automatically send information on all the available accessibility information/equipment that is available at that specific park.

Lesia Shelton reported she has been working on several projects with Vocational Rehabilitation and Missouri Commission for the Deaf and Hard of Hearing, addressing concerns related to education, accessibility, and language deprivation of Missouri's DHH students.

She is working on a project with NASA, that will give Missouri students opportunity to ask an astronaut a question - live from the International Space Station, on November 10th and will share additional information when it becomes available.
