Establishes treatment courts

This act establishes different types of treatment courts to address substance use or co-occurring disorders of substance use and mental health of specified groups within the court system. The groups include adults, juveniles, families, and veterans. The act sets guidelines for establishing treatment courts within circuits. The treatment courts will be responsible for establishing eligibility and completion criteria. The act changes the name of coordinating commission previously established for drug treatment courts, increases the membership, and adds responsibilities to the commission to establish standards for all treatment courts. It specifies administrative action will be taken against the courts that do not comply with the standards.

**SB 1081 - Rizzo**

Provides a procedure by which a defendant may be found to be not eligible for the death penalty due to serious mental illness

This act provides procedures and standards by which a defendant may be found to be not eligible for the death penalty due to a serious mental

illness if such illness was present at the time of the commission of the offense. A diagnosis of such serious mental illness may be made at any time prior to, on, or after the day of the commission of the offense and a defendant may raise the issue of a serious mental illness at any time to exclude him or her from eligibility for the sentence of death. If the defense raises the matter of the defendant's serious mental illness the court shall order an evaluation. Any information taken from such evaluation shall be protected and the evaluator shall not be called as a witness against the defendant, unless the defense first presents such information at a hearing. This act provides that if a defendant raises the matter of his or her serious mental illness and the state contests the application, the defense shall be entitled to a pretrial hearing and determination on eligibility. Such a motion shall have a rebuttable presumption that the condition significantly impaired the person's capacity at the time of the commission of the offense. A person's pleading of not guilty due to mental disease or defect or incapacity to stand trial, or a finding after such a plea that the person does not suffer from mental disease or defect or has capacity to stand trial, shall not preclude such person from any of the procedures provided by this act.

**SB 1035 - Koenig**

Enacts certain provisions relating to alternative special needs services for elementary and secondary education students

This act creates the Alternative Special Needs Services Act. The act allows a school district or charter school to enter into an alternative special needs services agreement with the parent or guardian of a special needs child, who is a child with disabilities or is severely handicapped, enrolled in a public school or charter school, and whose cost of education is estimated to exceed three times the current expenditure per average daily attendance. The agreement shall allow alternative special needs services to be provided by an independent provider, either solely or in conjunction with the services provided by the school district or charter school, that results in the reduction of expenditures by the school district or charter school and reimbursement costs paid by the Department of Elementary and Secondary Education for the educational costs of certain high-need children. The term of an agreement shall be for one school year, but may be modified or extended. The agreement may include provisions setting forth what percentage of time a special needs child shall attend a public school or charter school and what services the child's school district or charter school shall provide. No agreement shall be made that is not calculated to create financial savings to the school district or charter school and the Department. The district or charter school shall reimburse providers of special needs services pursuant to the provisions of the agreement.
